Grand Renewable Solar

10% Equity Ownership

GUNN'S HILL WIND FARM AND NIAGARA REGIONAL WIND FARM REACHED COMMERCIAL OPERATION IN FALL 2016

Six Nations of the Grand River Development Corporation (SNGRDC) is a 50% equity owner of FRWN LP., a 230 megawatt Wind Farm in Niagara Region and Haldimand County and a 10% equity owner of Gunn's Hill LP., a 10 megawatt wind installation in Oxford County. Not only will the projects bring in revenues no less than \$33 million over 20 year, they will also assist Six Nations' post-secondary students reach their academic goals through the creation of annual scholarships. Together, the two wind projects will bring \$480,000 worth of scholarships to Six Nations post-secondary students. These scholarships will be administered by Grand River Post-Secondary Education Office, over the next 20 years, on behalf of their respective projects.

CAPITAL POWER SCHOLARSHIP NOW AVAILABLE

The Capital Power Scholarship for students of Grand River Territory lineage, was established to support Haudenosaunee students pursue their post-secondary education aspirations in the field of **environmental studies, engineering or business**. This annual scholarship was negotiated on behalf of Grand River Post-Secondary Education Office and Capital Power by SNGRDC. The scholarship is fueled by a Community Benefit Agreement resulting from the development of the Nanticoke and Port Dover Wind Project. This year, four annual scholarships of \$2500 will be awarded.

PROUDLY SUPPORTS ANNUAL TOY BINGO FUNDRAISER

For over 15 years, Six Nations Bingo has hosted annual Toy Bingo fundraisers on behalf of local Elementary Schools. The Toy Bingo is one of the main fundraising activities for all Six Nations and New Credit schools raising approximately \$15,000 to \$25,000 per school, annually. Each school is responsible for collecting toy donations for their bingo, while Six Nations Bingo staff run the event and assist with advertising.

This year, seven schools from Six Nations and New Credit raised over **\$138,000** collectively.
