The Capital Power Scholarship for Haudenosaunee students of Grand River Territory lineage was established to support Haudenosaunee students to pursue their post secondary education aspirations in the field of **environmental studies, engineering or business** (accounting, finance, human resources). Individuals pursuing a college diploma, an undergraduate degree or a graduate degree are encouraged to apply. Community volunteerism and strong academic standing will be considered in the award of 4 annual scholarships of \$2500.00 by the Grand River Post Secondary Education Office on behalf of Capital Power.

Please note that only applicants meeting the criteria will be considered. All scholarship applications will be reviewed in September.

Criteria:

- Must be approved for GRPSEO funding for the upcoming academic year.
- Must be successful in all registered courses and a continuing full-time student in an accredited post secondary institution.
- An official transcript showing most recent activity of post secondary program.
- Graduate level (Thesis/Dissertation phase) – Academic letter of good standing required .
- A completed Community Service Activity form (form available on website at www.grpseo.org).
- Photo and commentary about your goals for school and future (maximum 150 words).
