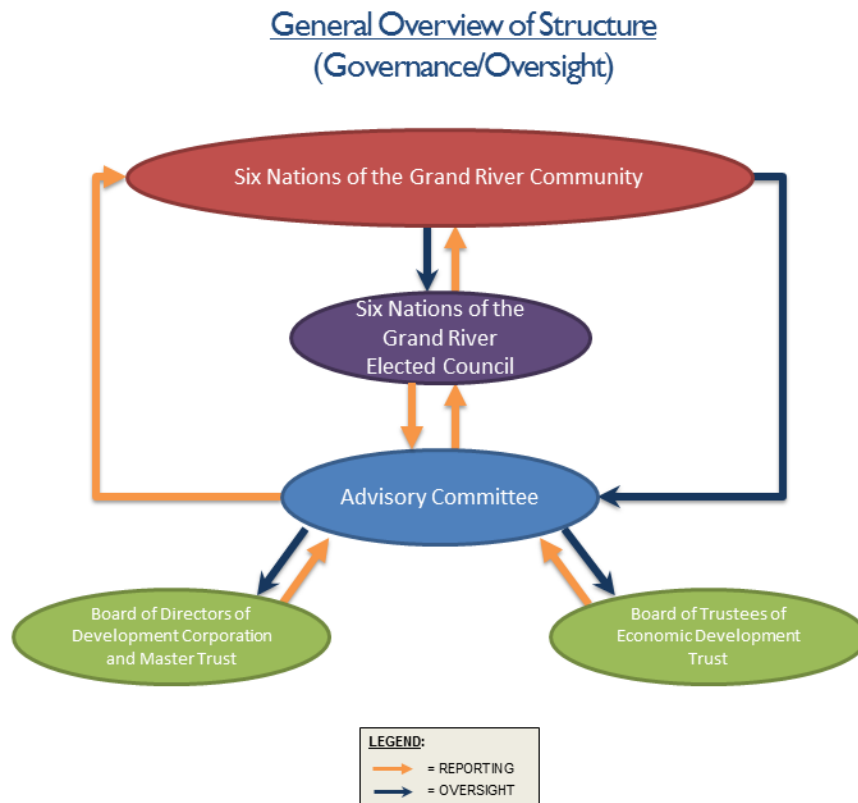
This call for applications is open to all Six Nations of the Grand River members. Prior to applying, please review this document to gain an understanding of the requirements of this position.

## **BOARD OF TRUSTEES OF ECONOMIC DEVELOPMENT TRUST**

**Mandate:** To determine how surplus profits generated by Six Nations of the Grand River Development Corporation are invested into the Six Nations Community for the collective benefit of its members.

### **Meeting requirements:**

- Regular Board meetings once a week on Wednesday.
- Weekend meetings are required throughout an application in-take.
- Quarterly informal business meetings with the Six Nations Elected Council.
- Quarterly All Board Meetings.
- Special meetings as required.

### **Roles and Responsibilities:**

- Determine the amount of all distributions of funds to be made by the Economic Development Trust in accordance with the Trust Indenture, Statement of Community Needs and Priorities, Community Plan and the Statement of Economic Development Trust Distribution Guidelines established by the Advisory Committee
- If determined by the Board of Trustees to be desirable, solicit, receive, evaluate and approve (or decline) proposals for funding from the Six Nations community

## **MINIMUM QUALIFICATIONS, EXPERIENCE AND SKILLS FOR TRUSTEES:**

- Registered member of Six Nations of the Grand River.
- 18 years of age or older.
- Of sound mind and good character.
- Not an elected official of Six Nations Elected Council nor an employee of the Six Nations of the Grand River Development Corporation.
- No direct or indirect conflict of interest.
- Socially responsible and knowledgeable about the Six Nations community, its culture and its needs and priorities.
- High ethical standards, integrity and reliability in professional and personal dealings.
- Appreciation of the principles of transparency and accountability to the Six Nations community.
- Ability to strategically plan for and prioritize the needs of the present and future generations of the Six Nations community.
- Knowledge and understanding of roles and responsibilities of a member of a governing board.
- Personal and professional skills match what the Corporation is seeking.
- Not bankrupt (successful candidates will need to provide proof).
- Satisfactory results of background checks, including from the Canadian Police Information Centre (CPIC).

## **DESIRED QUALIFICATIONS, EXPERIENCE AND SKILLS FOR ALL TRUSTEES:**

- Past volunteer or community involvement or similar experience.
- Ability and willingness to raise/deal with potentially controversial issues in a manner that encourages/maintains dialogue.
- Flexibility, responsiveness and willingness to consider others' opinions.
- Capable of wide perspective on issues.
- Ability to listen, communicate and work as a team member.
- Preferable experience in one or more of the following areas:
  - operating or administering, social programs or trust funds/grants;
  - education, employment, or training for community development;
  - risk management;
  - communications;
  - public policy
  - economics;
  - finance;
  - accounting; or
  - governance.
